#### **Chair's Report** CSCE Annual General Meeting

June 15, 2020

It is my honour to invite and welcome all members of the Calgary Society for Christian Education (CSCE) to join us at our annual general meeting on June 15, 2021.

As I write this, it looks like rain has replaced sleet and frosty nights may be behind us; as much as they ever are in Calgary. Spring is therefore upon us! By the time you read this, springtime in Calgary, our shortest season, may already have given way to summer but this year, more even than 2020, spring with all its promises is a welcome and needed reminder that after hardship and trial there is redemption and renewal. I hope and pray that all who have suffered in one way or another since the pandemic began will personally experience the redemption and renewal that is ours in Jesus and find in Him the strength to live each day anew, come what may.

In my last report of November, 2020, I expressed our thanks for all of the students, teachers and staff of Calgary Christian School (CCS) who have worked so hard to make the 2020/21 school year a success in very challenging circumstances. Thank you again. Thanks too are due to all of the parents, spouses and caregivers whose commitment to supporting them has made this possible. CCS is truly blessed by this community.

Since my last report, the board has continued to focus on core objectives. As outlined in Ken's report, CCS enrolment continues to meet or exceed our budget. We are particularly pleased to note that retention between grades 9 and 10 has improved markedly. Ken and the CSCE staff have been working very hard with CCS teachers, administrators, and staff to ensure that our service offering reflects the commitment to caring for each student and we believe the enrolment numbers are reflective of that. Our Covid-19 response has been ongoing and successful. We have received positive feedback on changes made to our cleaning and janitorial program and continue to work with Alberta Health to ensure that our facilities are a clean and safe place to be.

The board also continues to seek a path forward for expansion of our secondary school building. Recently the board has been looking at alternatives to traditional "brick and mortar" construction which will achieve our stated goals along with a with threefold benefit: at a lower cost, more in line with our new fundraising targets, and on a shorter construction timeframe. We are optimistic that these new possibilities will meet with your approval; our hope is to share project details with you on June 15 with a view to presenting the project and financing for approval in the fall.

In addition to these core areas of focus, the board has been working over the last 18 months on several other important projects. Building on the work of prior boards, we have strengthened the CSCE's finances through better long term forecasting, a revised fee structure, and the introduction of improved capital revenue and expense policies. At the same time, the board expanded the amount of financial assistance available for CCS students and maintained support for badly needed capital improvements. We have also been working on improving internal governance and accountability through the adoption or replacement of CSCE policies respecting, among other things, the integration of faith and learning, finance, and governance. The board has also had a number of conversations recently about how CCS and CSCE may be able to better reflect the racial diversity within our community and to better address issues of race and racism in a manner befitting those who worship the Creator of us all. As we prepare for a capital campaign to support the proposed secondary building expansion, the board has also authorized steps towards the creation of a foundation to ensure long term financial support for CCS.

I hope you will join me in offering sincere thanks to Lindy Coulliard and Harry Nutma who (along with me) have completed their respective terms of office and will be retiring from the board this year. The CSCE has benefitted greatly from their enthusiasm, their wisdom and their keen eye to detail over the past three years (actually, four years for Harry). It has been my privilege to serve with them. We are pleased that Steven Kroeker, our Treasurer, has agreed to allow his name to stand for a one year term extension to carry on with the great work he has brought to our financial planning and practices. We are also very excited to present to the membership for approval four new board candidates: Olubenga ("Benga") Adebayo, Jaco Venter, Matthew Weening, and Michelle Zuk, all of whom are passionate supporters of CCS. As you will see from their biographies, together they bring a wealth and diversity of experience.

This is my last update to you as chair of the CSCE board. I would again like to thank you for the opportunity to serve you in this way and pray that God will continue to bless our school and all of the members of the CCS community, so that we in turn may be a blessing to others.

#### **Executive Director's Report**

CSCE Annual General Meeting June 15, 2021

It is my pleasure to share with you how God continues to bless our learning community.

#### Student Enrollment

While our 2020-2021 school year started with 823 students in K-12 (a decrease from the previous year), improved retention and aggressive growth across all grade levels has raised our projected student population in excess of **885 students** for the coming year. This is an unprecedented, historic high. The need for additional learning spaces, especially at the secondary, has never been more pressing.

New families regularly complement CCS for providing a very personal and friendly approach to admissions, supported by prompt and detailed information. Many – including those moving to Calgary or immigrating to Canada - immediately feel welcomed and part of our community. Word of mouth and a well-equipped website continue to draw interested families to CCS.

#### Operations

Our team has made many and significant physical improvements to our elementary and secondary campuses in order to operate well under pandemic restrictions. This included washrooms upgraded with single touch faucets and door-less entries, removal of soft cloth furniture, modifying the layout of classrooms and common spaces to encourage physical distancing, plus entry way and in classroom hand sanitizing stations. A significant investment of time and resource was the addition of routine and repeated surface disinfecting. This required the equivalent of two, full-time employees to maintain the required level of disinfecting consistency.

Projects supporting continued 'best practices" for health will continue to be completed into the summer. These include installation of permanent sinks and hand washing stations in elementary classrooms that previously had none. And, the installation of a new HVAC unit above the 100 and 200 level classrooms, providing an improved heated, fresh air solution for those classrooms. We are fortunate to receive some Federal relief funding to compensate for these additional costs through the Palliser School District. We look forward to operating with the benefit of these improvements in the coming year and well into a post-pandemic future.

#### **Program Improvement**

Work continued on program definitions and other improvements to encourage the development of Christian character in students and provide a rigorous academic experience.

As reported last fall, a Christian Worldview Integration and Oversight policy and new Educational Staff Covenant had been adopted. The third element, known as the Grad Profile was in draft form and under review. Retitled the "CCS Learning Experience", the document has passed the review of staff and was presented to the Board in April for final review. We expect the final document to receive assent at the Board's June meeting.

Unlike a scope and sequence of studies, the Grad Profile is an "aspirational, memorable, and public commitment to redefine success in the terms of (essential) skills and habits of mind." Said another way, it is how we are specifying the "cognitive, personal and interpersonal competencies that students should have before they graduate." For CCS, this includes the

knowledge, skills and traits we believe identify the Christian character we work to develop in our students. (Quoted definitions are borrowed from *Global Online Academy* and *Edutopia*)

#### **Capital Improvement**

In addition to the pandemic-inspired improvements in our facilities, CSCE continues to faithfully attend to our campus' other physical needs, including repair and replacement of aging buildings, equipment, and systems.

The on-again / off-again presence of students and staff provided a few opportunities to initiate or complete work that might otherwise have been deferred to summer. Completed and in process projects at CCS include:

- A donated new-to-us-but-gently-used digital phone system replaces a failing and nolonger-supported analog phone system.
- Permanent sinks and cabinetry for handwashing in Grade 3 and 5 classrooms previously operating without.
- Year Two of roof repair projects this time, a steeply sloped area
- The LED lighting transition project continues. (We invest about \$20k annually to convert fixtures and/or bulbs as part of a total campus, multi-year conversion plan). The secondary basement and commons will be completed, as well as a Grade 5 classroom undergoing other improvements.
- Replacement of a roof top unit onto the 100/200 classroom building to provide heated fresh air. This corrects a nearly two decade deficiency, and will be funded in part with federal covid-relief dollars.
- Parking lot lines and new parking stops to replace weather deteriorated items. Barriers near the secondary entrance will be replaced with elevated concrete planters.
- Due to the significant increase in middle school population, we are purchasing additional desks and chairs, equivalent to an entire classroom.
- Fire alarm panel replacement
- Improved security for the front door of the secondary campus, allowing observation by cameras and an activated door lock controlled by admin staff.

Secondary Expansion Project = Secondary Improvement Project

As the impact of the C19 pandemic extended, questions were raised about the ability of CCS to raise adequate funding to support the proposed Phase I of the Secondary Expansion Project estimated at \$8.7MM. A second feasibility study was conducted quietly in the winter of 2020-2021 with many of the same respondents who participated in the fall 2019 study. The results indicated that a slightly lower amount of donations could be expected. In effect, this would require the CSCE to consider borrowing a larger sum to achieve the same goals.

Based on this new information, the Planning Committee and the Board asked if there were alternatives to the original plan that might achieve similar goals but at less cost. Among the solutions posed were focusing on more renovations of existing spaces, and a more limited new construction plan. It was noted that renovations could improve spaces, but would not add essential space; CCSS is already at a space deficit, especially where physical education and common areas are concerned.

Investigations since that time have yielded some interesting and highly probable solutions, all of which are scheduled to be unveiled during the meeting June 15.

God has been good to us through it all. We move forward with confidence and hope.
